Code of Conduct

STEP 9

In an effort to provide a positive, fair and professional competition environment, Quest Spirit Productions has implemented a Code of Conduct for all events. This Code of Conduct is to be followed by all coaches, competitors, family, friends or anyone else associated with below stated program.

As the coach of the _____ cheerleaders/dancers, I agree to the following guidelines.

RULES/REGULATIONS/SPORTSMANSHIP

- 1 I have read, understand and will abide by all Quest Spirit Productions rules and regulations.
- 2 I understand that competitive cheerleading or dance is an activity that presents the possibility of injury. As a coach who understands this risk, my athletes have received proper progression training.
- 3 I understand all risks associated with competitive cheer and will always place more emphasis on the safety of my athletes than on competitiveness.
- 4 I will follow all Quest Spirit Productions rules and regulations. I understand that any violation of these rules and regulations could result in a penalty point deduction, or, disqualification.
- 5 I will abide by the age and/or grade requirements (USASF/NFHS Guidelines) for all divisions that my teams are competing in. I understand that I will be required to provide proper age and/or grade verification at time of check in at an event. Falsifying age and/or grade requirements will result in disqualification from competition.
- 6 I will accept all judges' decisions as final and not question the integrity of said judges. If there is a valid protest, the head coach may file a complaint to Quest Spirit Productions. At no time may anyone other than the head coach file a complaint. If, for valid purpose, I register a complaint, I understand that this complaint will be addressed after the competition.
- 7 I understand that any action taken by a parent, family member, friend or competitor in approaching a Quest Spirit Productions staff member or judge will result in a penalty point deduction as well as forfeiting the coach's right to protest or review tape.
- 8 At all times, I will support results of the competition as I am a role model for my program.
- 9 I will promote fairness and demonstrate appropriate sportsmanship throughout the competition, as well as require all persons affiliated with my program to conduct themselves with the same appropriate sportsmanship. This includes if a division of mine is being combined with small teams and a large or vice versa. I am for the spirit of the competition.
- 10 I understand that Quest Spirit Productions reserves the right to remove any persons from a competition for unsafe or unsportsmanlike actions.
- 11 I understand by signing this, I am giving Quest Spirit Productions, LLC. Permission to use my team/gym name on their website, brochures and/or all other promotional materials.

Force Majeure: Quest Spirit Productions shall not be liable for failure or other delay in performance of it obligations under any agreement to the extent such failure or delay is due to circumstances beyond its reasonable control, including, without limitation, acts of God, acts of public enemy, fires, floods, war, civil disturbance, participation, sabotage, lock-outs, labor disputes, acts of any governmental or quasi governmental authority, theme park, or any other force majeure.

Waiver & Release Form

Please complete all sections of this form. This agreement MUST be completed and signed in order to participate. By signing this release form, I acknowledge and understand the cheerleading is a vigorous athletic activity that includes, but not limited to, tossing, falling, running, jumping, stunting, building, pyramids, tumbling and dancing. Due to the nature of this type of activity, the possibility of injury to death could occur. By signing this agreement, you agree that yourself or your child (to be known as "minor" from this point on) is physically fit to participate in this activity and has no known medical conditions that may compromise the safety of yourself, the minor, other participants and facilitators of the event

Liability Release, I _____, as a legal participant or parent or legal of _____, (a Minor), here by grant the permission necessary to allow guardian myself or Minor to participate in the above event to be conducted by Quest Spirit Productions, LLC. I, in my own behalf and behalf of the minor, further agree to release and to hold harmless Quest Spirit Productions, LLC, Inc., the hosting site (gym, school, hotel, university, theme park, arena, convention center) on whose premises the event will occur (here inafter the "Location") the affiliates of Quest Spirit Productions, LLC and the Location, and the respective doctors, officers, representatives, members, agents and employees of Quest Spirit Productions, LLC and their representative affiliates (hereinafter collectively "Releases") from any and all liability whether caused by the negligence by the "releases" or otherwise for any claim judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the event, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that myself or the Minor may incur or sustain during the event, all activities associated with the event and while traveling to and from the site for the event whether or not the event actually occurs. I am signing this for myself being of legal age as an adult and/or for a minor. I, in my own behalf and on the behalf of the Minor, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents. I am aware that this Liability Release releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumptioun of the risk of injury or illness. I further acknowledge that nothing in this Liability Release constitutes a guarantee that the event will occur. I have signed this document voluntarily and of my own free will.

Medical Release, I acknowledge and agree that such participation subjects myself or the Minor to the possibility of physical illness or injury (minimal, serious catastrophic and/or death) and that I, in my own behalf and on the behalf of the Minor, acknowledge that myself or the Minor is assuming the risk of such injury or illness by participating in the event.
